## Enhancements To EXR Experience Rating Worksheet Lookup Effective August 6, 2007

This announcement is intended for customers using EXR, the Experience Rating Worksheet Lookup product. Enhancements have been made to EXR that will allow the user to use this product more effectively. These enhancements include:
